PRACTICE

Sir Thayne Forbes is an arbitrator, adjudicator and mediator and chair of high profile public inquiries.

Following a successful career at the bar from 1966 to 1990, becoming Queen's Counsel in 1984, he was made Official Referee from 1990 to 1993. He was then appointed as a High Court Judge and assigned to the Queen's Bench Division and 2 years later as Presiding Judge of the Northern Circuit until 1999.

From 2001 to 2004 he was the judge in charge of the Technology and Construction Court. He was then Chair to the Working Group set up by the Judges' Council to report on judicial welfare and support in 2005/6 and following the Working Group's report was asked to Chair the Judges' Council's Standing Committee on judicial welfare and support. This committee has produced two further reports. At the request of the Lord Chief Justice, Sir Thayne continues to act as the chair of the Standing Committee and as the person with portfolio responsibility for judicial welfare for England and Wales. He retired from the High Court Bench in January 2009.

PUBLIC INQUIRIES

In a written statement given on Wednesday 2 November 2009, the Secretary of State for Defence, The Rt Hon Bob Ainsworth MP announced that there would be a public inquiry into the allegations that Iraqi nationals were detailed after a firefight with British soldiers in Iraq in 2004 and unlawfully killed at a British camp, and that others had been mistreated at that camp and later at a detention facility and accordingly Sir Thayne Forbes was appointed Chairman of The Al-Sweady Public Inquiry.

ARBITRATOR

Sitting as arbitrator regarding a dispute in connection with the provision of electricity.

ADJUDICATION

• Sitting as adjudicator on a dispute relating to a £220m NHS Trust PFI project. The dispute concerned the ventilation and air-conditioning requirements on the construction of a new Oncology Centre.

MEDIATION

- Successfully mediated on a £900m construction dispute in relation to the design of structural engineering works at the new Wembley National Stadium;
- Sitting as mediator regarding a multi-party high value TCC dispute over the construction of a premium quality residential property in West London.
