## **PRACTICE**

Sheriar joined Atkin Chambers as a tenant in September 2023, following successful completion of his pupillage. Sheriar graduated with a first-class degree in Law from the London School of Economics and Political Science (LSE) before reading for a Master of Law from the University of Cambridge.

Prior to commencing pupillage, Sheriar spent eight months working at the High Court as a Judicial Assistant. During part of this time, Sheriar was the Judicial Assistant to Mrs Justice O'Farrell (Judge in Charge) and Mr Justice Waksman in the Technology & Construction Court.

Sheriar previously lived in Frankfurt where he undertook a year-long traineeship with Freshfields Bruckhaus Deringer's international arbitration team and worked on several international commercial arbitrations.
